Section 12-201.11(A)(1) of the Wisconsin Food Code requires that the operator or manager of a restaurant that is new or has changed hands shall become certified in safe food handling practices within 90 days after opening. 2) Food establishments which are not in compliance because of employee turnover or other loss of a certified manager, shall have 90 days from the date of the loss of a certified manager to comply with the Food Code, or provide documentation that the person designated to be the certified food manager will become certified within the time specified in this subparagraph.

The exam will be taken on a scantron form (small bubbles to fill in), if you use reading glasses, it may be necessary to bring them with you.

The exam is available in different languages. A two week notice must be given to order the exam. Languages available are: Arabic, Japanese, Korean, Modern or Traditional Chinese, Spanish and Vietnamese.

SMALL OPERATOR TRAINING COURSE

As of January 2015, all owners or managers who renewed a (CFM) Certified Food Managers license had to show the food inspector proof of passing a nationally accredited food protection examination. With the passage of Act 9, small restaurants with five (5) or fewer food handlers are now exempt from renewing their CFM license by completing a nationally accredited food protection examination. Instead, small restaurant operators or managers have the option to take a Food Safety Training for Small Operator course.

With restaurants with more than five (5) food handlers, nothing has changed. This law only changes the renewal process for owners and managers of small restaurants that choose not to renew their license by exhibiting competency on an examination. Instead you will be issued a small operators permit, which allows you to operate without a Certified Food Managers License. Our exam will be very informal.

COURSE DETAILS:

- Photo ID (Driver License) is mandatory to take the course!!
- For Class Confirmation call 1-800-445-9221.
- Bring a #2 pencil and a highlighter pen.
- Alcoholic beverages are not allowed in room during class or exam.
- Classes with less than 10 people may be cancelled or rescheduled. If you are pre-registered you will be notified prior to class in the event of a cancellation.
- The use of electronic devices, recording devices and cell phones is prohibited during the class.
