Section 12-201.11(A)(1) of the Wisconsin Food Code requires that the operator or manager of a restaurant that is new or has changed hands shall become certified in safe food handling practices within 90 days after opening. 2) Food establishments which are not in compliance because of employee turnover or other loss of a certified manager, shall have 90 days from the date of the loss of a certified manager to comply with the Food Code, or provide documentation that the person designated to be the certified food manager will become certified within the time specified in this subparagraph.

RECERTIFICATION COURSE

Section 12-401.11 RECERTIFICATION (A) A certificate issued under this section may be renewed within six months of expiration, if the certified manager successfully completes a recertification training course. The recertification training course shall be completed prior to issuance of a new certificate. If recertification is not completed within 6 months after your original expiration date, you will be required, by the state, to attend the original certification course. The course shall consist of at least 3 hours of instructional time, as required by the State of Wisconsin, and include an examination on the information presented.

Our exam will be very informal.

A Certificate of Completion will be mailed to you within 2 weeks of completing the course.



COURSE DETAILS:

- Photo ID (Driver License) is mandatory to take the course!!

- Bring a #2 pencil and a highlighter pen.
- Smoking or alcoholic beverages are not allowed in room during class or exam.
- Classes with less than 10 people may be cancelled or rescheduled. If you are pre-registered you will be notified prior to class in the event of a cancellation.
